

1. May 5, 2017: Revision of Non-Discrimination Statement

On May 5, 2017, the President of Criswell College approved a Non-Discrimination Policy which revised the college's non-discrimination statement originally published in the 2017-2018 Catalog. The new statement, which replaces the statements on pages 1 and 22 of the Catalog, reads as follows:

Criswell College admits students who are Christians of good character, without regard or reference to race, national or ethnic origin, color, age, disability, or sex (except where regard to sex is required by the College's religious tenets regarding gender and sexuality) to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of these classifications in administration of its educational policies, admissions policies, scholarship and loan programs, and other school-administered programs.

2. August 10, 2017: EMS 417/International Mission Practicum Replaced with EMS 428/Global Service Practicum

On August 10, 2017, the Vice President of Academic Affairs of Criswell College approved the replacement of EMS 417/International Mission Practicum (originally published on page 100 of the 2017-2018 Catalog) with a new course: EMS 428/Global Service Practicum. The description of the new course reads as follows:

EMS 428

Global Service Practicum

A study of the biblical and theological foundations of Christian mission, coupled with the use of demographic and ethnographic research, in preparation for effective short-term cross-cultural global service projects. (Course open only to Juniors and Seniors; Prerequisites: THS 101, EMS 101; Students must take EMS 428 and EMS 429 within a single academic year.)

3. August 10, 2017: Addition of EMS 429/Global Service Practicum Lab

On August 10, 2017, the Vice President of Academic Affairs of Criswell College approved the addition of a new course to the 2017-2018 Catalog: EMS 429/Global Service Practicum Lab. The description of the new course reads as follows:

EMS 429

Global Service Practicum Lab (Non-credit)

A short-term, global travel course, designed to expose students to serving cross-culturally. (Prerequisite: EMS 428; Students must take EMS 428 and EMS 429 within a single academic year.)

4. August 10, 2017: Curriculum Revision to the Ministry Core Studies in all Bachelor of Arts and Bachelor of Science Programs

On August 10, 2017, the Vice President of Academic Affairs approved a revision to the curriculum of the Ministry Core Studies in all Bachelor of Arts and Bachelor of Science programs. The new Ministry Core

Studies curriculum, which replaces the Ministry Core Studies curriculum on pages 83, 85, 87, 89, and 91 of the 2017-2018 Catalog, is as follows:

5. August 18, 2017: Revision to Spring Break Dates and Final Exam Date for Term 1 in SP-18

On August 18, 2017, the Vice President of Academic Affairs, in conjunction with college faculty, approved changing the dates for spring break and the final exam date for Term 1 in the spring 2018 semester. The new dates, which replace those on page 5 of the 2017-2018 Catalog, are as follows:

Spring Break: March 12-16, 2018

Term 1 final exams in spring 2018: March 23, 2018
