# **Course Description and Prerequisites**

A study of Anabaptists and their origins is followed by an examination of the emergence of the English Baptists and their subsequent history. A discussion of the history of Baptists in the U.S. emphasizing Southern Baptists. Stress is placed on the distinctive beliefs of Baptists within the context of the broader reformation heritage.

# **Course Objectives**

At the end of this course, the student should have the ability to . . .

- 1. Articulate a working knowledge of the significant phases, events, and persons in Baptist history and significant terms and concepts regarding Baptist doctrine.
- 2. Recognize how Baptist ministry (doctrine and practice) has been influenced by contemporary and antecedent forces and develop a sense of discernment regarding the forces impacting his or her ministry.
- 3. Encourage others as to their place in the history of God's work especially as they find themselves in or impacted by the Baptist movement.
- 4. Enunciate the warrant for Baptist doctrinal distinctives while engaged in sympathetic but critical dialogue with other Christian communities, traditions, and denominations.
- 5. Compose a scholarly review of a recent contribution to the field of Baptist History and Distinctives. 1

# **Course Requirements and Assignments**

- 1. Reading Assignments (20%): Students will report the percent of reading completed on each day that a quiz is scheduled. For example, on Quiz 2 the percent of the assigned reading for the Blount/Wooddell text (pages 55–81) and the McBeth text (pages 64–150) will be reported. There is no credit for reading that is not completed and reported by the beginning of the class in which it is due. Students who are going to be absent should e-mail the percent of reading completed to the professor prior to the beginning of class.
- **2. Quizzes (20%):** There will be seven (7) quizzes. They will be administered during the first fifteen minutes of class on the dates indicated on the schedule below. Each quiz will cover material in the McBeth text on the pages assigned since the previous quiz (e.g., Quiz 1 will cover pages 19–44 and 44–63). They are not cumulative. No make-up quizzes will be offered. The lowest quiz grade will be dropped.
- 3. (Final) Research Assignment (30%): Research will be conducted over the course of the semester on the Baptist articulation of a specific doctrine. After consultation with the professor and by the date of the first quiz, February 12<sup>th</sup>, each student will choose a doctrine to be researched.

### **Sources for Research:**

- 1. At least one primary source from each century—17<sup>th</sup>, 18<sup>th</sup>, 19<sup>th</sup>, 20<sup>th</sup>, 21<sup>st</sup>. You must <u>cite</u> (i.e., with the use of footnotes) pertinent sections from each source in your paper and explain how it shows continuity or discontinuity with other primary sources. <u>List</u> these sources in the bibliography.
- 2. A minimum of eight secondary sources. You must <u>consult and list</u> these sources in a bibliography. A maximum of three may be reference books (e.g. dictionaries, encyclopedias, general texts). A maximum of three may be significant on-line resources.

### **Presentation of Research:**

The student will work alone and present the results of the research in a 10–13 page (2500–3250 words; excluding cover and bibliography) paper due <u>May 14th</u>. The paper will display an in-depth knowledge of the Baptist articulation of a specific doctrine and will be structured as follows:

- 1. 1 page (250 words) Introduction.
- 2. 8-10 pages (2000–2500 words) Exposition of the Baptist articulation regarding the doctrine chosen. It will answer the question, "Over the course of Baptist history, how has the Baptist articulation of this doctrine remained the same and how has it changed?" It should include citations from confessional statements, and references to significant figures and events.
- 3. 1½ -2 pages (375–500 words)— Personal application. Examples of questions that could be answered: How have you seen this doctrine manifest in your local congregation? If you haven't seen it manifest, identify possible reasons for this absence. How will you incorporate the truths you discovered in your research on this doctrine into your ministry? What questions were raised in your mind as you learned more about this doctrine *and* how were you able to find answers to these questions?
- 4. Bibliography of sources cited and consulted.

<u>Form and style:</u> The *Criswell College Manual of Style* must be consulted for proper form. Spelling, grammar, and punctuation will be considered in the grading. Only the first 13 pages of the paper will be graded.

<u>Due Date and Late Penalty</u>: The paper is due by the beginning of class (**4:15 pm**) on <u>May 14th</u>. It may either be e-mailed to the professor or brought to class. (If it is e-mailed, a response will be provided with 24 hours indicating receipt of the paper. If the student does not receive a receipt message from the professor, it is up to the student to contact the professor to arrange for alternative delivery.) If it is not submitted on time, a student earns an automatic extension penalty of 10 points with an additional 10-point deduction for every day thereafter.

Extra Credit: Up to 20 points are available to students who will present their paper to the class on December 10th. The student will provide a handout to all members of the class. This handout may be an outline or summarization of the paper, pertinent extracts from the primary sources under consideration, or the entire paper. The student will read their paper and then be ready to answer questions from the professor and class. (Note: The student is responsible for making enough copies to distribute to all class members. If a student would like to have the professor make the copies of the handout and bibliography, it should be submitted no later than 8am on Tuesday, May 14th).

### 4. Book Review (30%)

Each student will prepare a journal-level review of a recently published book in the field of Baptist History and Distinctives. A successful review will meet the formal requirements obtained from the book review editor of an academic journal and will demonstrate that the student has mastered the book's claim, warrant, conclusions and approach. The book to be read and reviewed will be chosen in consultation with the professor by the sixth class session, **February 26th**. It must be a book published in the past two years and may be one of the secondary sources used in the Research Assignment for this course.

The student will contact the book review editor of an academic journal in order to obtain the guidelines for book reviews and submit a copy of these guidelines to the professor by the seventh class, **March 5th**.

The first draft of the book review will be submitted by the ninth week of class, **March 26th**. The second draft of the book review will be submitted by the eleventh week of class, **April 9th**. The final draft of the book review will be submitted by the fourteenth week of class, **April 30th**. (The second and final drafts should have the previous drafts with the professor's notes attached. The reviews should be double spaced. The word count of the review should be listed at the end regardless of whether it is a part of the journal's guidelines for book reviews.) No late final drafts will be accepted.

### 4. Extra Credit

Extra credit is available for students who attempt and then track their grades in the course without the use of Canvas.

- .5 point: added to a student's final grade if he or she indicates by the second week of the semester that he or she intends to not use Canvas for tracking grades.
- 2 points: added to a student's final grade if he or she completes the semester without utilizing Canvas to access their grades.
- .5 point: added to a student's final grade if he or she completes a short survey at the end of the semester regarding the experience tracking grades either with or without Canvas.

Rationale for this extra credit: More and more institutions and professors are using Learning Management Systems such as Canvas as a depository for student grades. I believe this is an unhelpful trend and counterproductive for student success in meeting course learning objectives. First, it encourages the student to obsess about the number grade on any given assignment rather than the content that resulted in that grade. Second, Canvas does not provide tools for the student to project their grades. Third, it discourages students from staying in contact with the course professor or grader.

I believe that my approach for providing grades is better for your success in this course. I grade your work myself and return that work to you through the semester with the intention that you use that work to learn and grow further. I encourage you to contact me directly at any point (or points) through the semester regarding grades. I will provide you with your current grades and, more importantly, I will help you project your grades through the end of the semester given a number of scenarios based on the realities you are facing in the classroom.

# **Course/Classroom Policies and Information**

**Recording:** Students may not record class sessions in any media. If a student desires to record a class session, written permission must be obtained in advance of the recording. Please submit a written request explaining the purpose of recording and the extent of use of the recording. Under no conditions may recordings be duplicated, given, or lent to anyone who has not been granted permission by the professor.

**Textbooks:** The selection of textbooks should not be interpreted as implying the professor's endorsement of any of the views of the authors. Textbooks are selected for their perceived value in helping to meet the course goals and objectives.

### **Class Attendance**

Students are responsible for enrolling in courses for which they anticipate being able to attend every class session on the day and time appearing on course schedules, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any information missed. Professors are not obliged to allow students to make up missed work.
