## **Course Description and Prerequisites**

An advanced examination of selected books in the English Bible. (Course may be repeated for credit when the Bible book differs; Prerequisite: NTS 501 or equivalent; Prerequisite may be taken concurrently: NTS 601 or equivalent).

# **Course Objectives**

- 1. Be able to discover the scope (theme) and the design (outline) of the Gospel of John
- 2. Become knowledgeable of the socio-political context in which the Gospel was written,
- 3. Grasp the issues facing the original congregations that necessitated the writing of the Gospel,
- 4. Recognize the importance of the Gospel of John on the following issues: Jesus' identity, light versus darkness, persecution of believers, ethical behavior, Pharisaic Judaism, Temple and Passover.
- 5. Know the various interpretative issues in order to teach and/or preach the books in a church setting.

#### **Required Textbooks**

Michaels, J. Ramsey. The Gospel of John (NICNT). Grand Rapids: Eerdmans, 2010.

# **Course Requirements and Assignments**

- 1. Reading. The student will read weekly assigned pages out of the text and take a weekly quiz on the materials. Counts 20% of semester grade.
- 2. Papers. Using the J. Ramsey Michael, plus four starred (\*) commentaries from the bibliography. The student must interact with the commentators and show how each agrees or disagrees with Michaels. The student will prepare TWO 10 page exegesis paper on a passage in The Gospel of John and present them to class. Counts 40% of semester grade.
- 3. Attendance. Students are expected to attend all class sessions, both arriving on time and not leaving until the session is over. A grade will be given for attendance. One absence per semester will be allowed

- without penalty. Two absences, 91; three absences 81; four absences, 71; five absences 61; six absences, 51, etc. Counts 10% of semester grade.
- 4. Discussion and class participation. The student will participate in class discussions and ask probing questions of the presenters. Counts 10% of semester grade.

# **Course/Classroom Policies and Information**

No computers or cell phone may be used in class. Students may record the class upon professor's approval.

#### **Class Attendance**

Students are responsible for enrolling in courses for which they anticipate being able to attend every class session on the day and time appearing on course schedules, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any information missed. Professors are not obliged to allow students to make up missed work. Per their independent discretion, individual professors may determine how attendance affects students' ability to meet course learning objectives and whether attendance affects course grades.
