Course Description and Prerequisites

Applied Ministry Project Non-credit

A practical application of Christian ministry in diverse areas, such as discipleship, Christian counseling, Bible study leadership, chaplaincy, street evangelism, hospital visitation, etc. (A position of ministry in a local church will satisfy this requirement if approved by the Director of Applied Ministry. This is required each semester for all full-time students taking nine or more credit hours.)

Course Objectives

- 1. To engage in Christian ministry through a local church or other approved ministry project.
- 2. To complete the minimum of 16 hours of service in Christian ministry during the semester and report it in Canvas during the semester.
- 3. To integrate theoretical knowledge in the classroom with practical experience in a ministry field.

Course Requirements and Assignments

- A. All full time graduate students (9 credit hours or more) must report an Applied Ministry Project at the beginning of each semester. At registration, they will sign an agreement to complete a chosen project which will require a minimum of 16 hours to be completed during the semester. (For possible examples of approved projects, see subsequent listing.)
- B. Students who cannot provide an Applied Ministry Project report during registration must submit their project in Canvas during the semester by the deadline at the end of the semester.
- C. All full time graduate students who do not complete their Applied Ministry Project by the deadline at the end of the semester will have a hold placed on their account and it will prevent them from registration the following semester.
- D. This is a non-credit course and students receive credit (CR) or no credit (NC) for the semester. Note: The grading scale on the following page does not apply.

Attendance

Students are responsible for enrolling in courses for which they anticipate being able to participate weekly during the weeks appearing on course schedules, and then making every effort to do so. Such participation may include the following: completing quizzes or exams; emailing faculty or class members as part of an assignment; discussion board posting or response; turning in an assignment; or other communication reflecting ongoing learning in the course. When unavoidable situations result in non-participation, students are responsible for acquiring any information missed. Professors are not obliged to allow students to make up missed work. Per their independent discretion, individual professors may determine how participation affects students' ability to meet course learning objectives and whether participation affects course grades..

Incomplete Grades

Students requesting a grade of Incomplete (I) must understand that incomplete grades may be given only upon approval of the faculty member involved. An "I" may be assigned only when a student is currently passing a course and in situations involving extended illness, serious injury, death in the family, or employment or government reassignment, not student neglect.

Students are responsible for contacting their professors prior to the end of the semester, plus filing the appropriate completed and approved academic request form with the Registrar's Office. The "I" must be removed (by completing the remaining course requirements) no later than 60 calendar days after the grade was assigned, or the "I" will become an "F."
