Course Description and Prerequisites

Topics chosen from such areas as equations and inequalities; polynomial, rational, radical, exponential, and logarithmic functions. (This course satisfies for a Math/Natural Science course.)

Course Objectives

Equations and Functions: apply general graphing and algebraic techniques for solving equations and inequalities; define, graph, and recognize various types of functions.

Linear and Quadratic Functions: solve linear and quadratic equations; solve application problems involving linear and quadratic equations

Polynomial and Rational Functions: recognize, graph, and analyze polynomial and rational functions; factor polynomials into linear factors

Exponential and Logarithmic Functions: solve and graph exponential and logarithmic equations; solve application problems involving exponential and logarithmic functions

Systems of Equations: solve systems of equations and related application problems

Sequences and Series: Recognize and apply the properties of sequences and series to solve application problems

Incomplete Grades
