Course Description and Prerequisites

A study of English style and usage in written and oral expression. Critical thinking, research, and writing skills necessary for success in courses across the curriculum. Prerequisite: COM 101.

Course Objectives

- a. Enhance ability to
 - i. Write efficient, well-developed outlines, body paragraphs, and sentences
 - **ii.** Analyze and critique scholars, peers, and texts
 - iii. Synthesize research into categories in order to evaluate and critique their findings
 - iv. Utilize sources in appropriate manual style
- b. Engage with readings actively and efficiently
- c. Use proper diction in formal essays
- d. Write a well-researched literature review
- e. Find and develop a thesis, one that is appropriate for the academic conversation
- **f.** Understand how to write a clear and logical essay, with an introduction, thesis, topic sentences, concrete details, commentaries, and conclusions
- g. Know how to edit and critique essays
- **h.** Understand/master the research and writing process

Course Requirements and Assignments

- **a.** Participation and Daily Assignments. This portion of your grade will be earned by coming to class with the readings done and readiness to participate in class discussions. (10%)
- b. Annotated Bibliography. Take a normal bibliography page (with 3 academic sources), and underneath each source citation, draft a paragraph that identifies that author's thesis, at least one supporting point, your evaluation of the source, and how you can use that source with the other sources. (20%)
- c. Peer editing assignments. You must peer edit your classmates' response papers and research essays. [10%]
- d. Rhetorical Analysis. Choose a text to evaluate/analyze: poem, fiction, movie, play, art, commercial, or scholarly text. Read, annotate, and critique that text, and write up your analysis in a short paper that includes your judgment, criteria, and proof. (30%)
- e. Literature Review, which will serve as your final exam. This 3-4 page essay requires 5 sources: 1 academic book, 2 academic articles, and 2 sources of your choosing). You will submit two drafts during the semester: rough draft and final draft. For final drafts, students are expected to address ALL remarks from the first draft. [30%]

Course/Classroom Policies and Information

- I reserve the right to ask a student to leave if he or she is being disruptive or uncooperative.
- Technology is allowed in the classroom until it becomes a distraction.
- Daily work must be completed by the start of each class period; no late work will be accepted.
- Peer review will be done in class, but writing assignments are due by 11:59 PM on our class day (10-point penalty per class period).
- Students can miss two class periods, but on the third absence, the student's grade may be affected.

Class Attendance

Students are responsible for enrolling in courses for which they anticipate being able to attend every class session on the day and time appearing on course schedules, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any information missed. Instructors are not obliged to allow students to make up missed work. Incomplete Grades
