Course Description and Prerequisites

Introduces the foundations of the profession of education to the beginning pre-service teacher. The educational philosophies and methodologies of various periods, as well as current trends in public and private education in America, are reviewed. Also included are how these philosophers and trends affect learners, law, and instructional methods. (Nine clock hours of field experience are required for this course.)

Course Objectives

- 1. Discuss the characteristics of effective and ineffective teachers.
- 2. Discuss the contributions of historical and current education reform initiatives.
- 3. State the basic tenets of educational philosophies and determine which have a biblical foundation.
- 4. Write and explain your personal philosophy of education.
- 5. Research and report on many of the ethical and legal issues facing teachers today.
- 6. Begin developing your own personal approach to today's schools, teaching, students, and classroom management after personally observing professional teachers at work.
- 7. Plan a differentiated lesson based on the characteristics of various learners, their developmental needs, and intelligences.

Course Requirements and Assignments

Late Work Classroom Policy: Work is due at the beginning of class on the date designated unless otherwise stated by the professor. Late work will not be accepted.

1. Educator Biography: You will choose a person who has made a significant contribution to the field of education. You will then write a two (2) page biography of that person. This paper must be typed, double spaced, and 12cpi. You will be expected to share what you have learned.

DUE: 2/02/21 POINTS: 5 points

2. Peer Teaching #1: You will develop a lesson that focuses on an assigned curriculum area. You will be given a lesson plan format on which to base your own typed lesson plan. The lesson is to last from 5 to 10 minutes and include some type of visual or manipulative aide. The lesson is to be thorough and of a professional standard.

DUE: 3/02/21 POINTS: 10 points

3. Electronic Professional Portfolio: The requirements for this assignment will be distributed to all Education majors during the first Program meeting.

DUE: 4/06/21 POINTS: 5 points

4. Field Experience Journal: You will record your observations and reflections of your field experience in nine (9) entries. A format for your journal will be provided for you in class. All nine entries are to follow this format *and are to be typed*. Two-thirds of your grade on this assignment will come from the journal, and one-third of your points will come from your discussion of your experiences.

DUE: 4/20/21 POINTS: 15 points

5. TEA Research Paper: You will choose an aspect of Texas education governance to investigate. This research paper is to be a minimum of two (2) pages in length. It must be typed, double spaced, and 12cpi. You will be expected to share what you have learned.

DUE: 4/20/21 POINTS: 5 points

6. Reform Issue Paper: After choosing a reform issue to investigate, you will write a two (2) page research paper. This paper must be typed, double spaced, and 12cpi. You will be expected to share what you have learned.

DUE: 4/27/21 POINTS: 5 points

7. Current Events Scrapbook: This scrapbook is to be a reflection of current (Jan. 2019 to Dec. 2019) issues in local, state, and national education. There are to be 15 articles in the scrapbook. Ten (10) articles are to be about public education and five (5) are to be about Christian education. All the articles are to be neatly mounted and accompanied by a one paragraph written summary and a one paragraph written response. Each article must be notated as to source, date, and author.

DUE: 5/04/21 POINTS: 10 points

8. Personal Educational Philosophy Paper: This assignment is to aid you in developing your own philosophy of education. This is not a research paper; therefore it is to be written in "first person." The paper is to be 5-7 pages in length, typed, double-spaced, and 12cpi. It is to address a number of basic questions about education that will be provided for you in class. Your philosophy must be supported with a minimum of five (5) scriptures.

DUE: 5/04/21 POINTS: 15 points

9. Class Notes: All chapter outlines are to be completed by you during the semester. Class discussions will cover portions of the notes. However, it is understood, that time constraints do not permit completion of all outlines during class. Therefore, it is your responsibility to complete the remainder of the outlines during your own studies of the text material.

DUE: 5/04/21 POINTS: 5 points

10. Elaborated Peer Teaching: This lesson will be presented in lieu of a Final Exam. It will cover a different portion of the elementary curriculum than the Peer Teaching #1 assignment. The lesson must be 10 to 15 minutes in length. It will be accompanied by a more extensive typed lesson plan (the form will be provided in class) and a visual or manipulative aide. The lesson is to be thorough and of a professional standard.

DUE: 5/11/21 POINTS: 15 points

11. Tests: Two tests will be administered during the semester. They will cover material from the text and class discussions.

On-Campus Course Syllabus ADDENDUM FOR SP 21 EDU 200 L1 Introduction to Education

In the event that Criswell College has to close the campus to on-campus classes in during the SP-21 semester, this addendum specifies how your instructor intends to adjust the course in order to allow students to meet the course objectives.

The course requirements, assignments, calendar, and attendance requirements from the syllabus for this course are replicated below.

Course Requirements and Assignments

Course requirements, assignments, and due dates will remain in place if this course must become a remote learning situation due to COVID restrictions.

Class Attendance

Students will be expected to fully participate in the course in spite of the COVID restrictions or protocols.

Remote Class Sessions: Identity and Participation Verification
