Course Description and Prerequisites

A study of selected topics related to the language, history, background, hermeneutics, or theology of the New Testament. The topic this semester is an introduction to exegesis. (Prerequisites: NTS 101, NTS 201.)

Course Objectives

This course will:

- 1. Provide students with a framework for better understanding the exegesis of the New Testament.
- 2. Provide students with practical experience and feedback using exegetical tools.
- 3. Explore ways of using exegetical tools within a ministry context.
- 4. Encourage students to develop a plan for consistent future exegetical work.

Course Requirements and Assignments

The student's final grade for the class will be based on a series of ten assignments. Further instructions and requirements will be given in class. The following is a list of the assignments with their relative weights and a brief description:

- Synthetic Observations (5%) A list of observations from a synthetic study on a given New Testament book. Due Oct 4.
- 2. Book Chart (15%) A synthetic book chart of a given New Testament book. Due Oct 18.

- 3. Structural Layout (10%) A structural layout of a given New Testament passage with a given translation. Due Oct 25.
- 4. Plot Diagram (5%) A plot diagram of a given New Testament narrative passage. Due Nov 1.
- 5. Exegetical Outline (15%) Subject-complement statements that fill a given outline framework for a New Testament passage. Due Nov 15.
- 6. Word Study (10%) A diachronic word study for a given New Testament term. Due Nov 29.
- 7. Validation Paper (10%) A validation paper on a given New Testament problem passage. Due Dec 6.
- 8. Topical Study (10%) An overview study of a given New Testament topic. Due Dec 10.
- 9. Curricula Assignment (15%) Discussion questions for a given New Testament passage. Due Dec 10.
- 10. Calendar Assignment (5%) Topical preaching/curricula calendar. Due Dec 10.

Course/Classroom Policies and Information

Class Attendance

Students are responsible for enrolling in courses for which they anticipate being able to attend every class session on the day and time appearing on course schedules, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any information missed. Instructors are not obliged to allow students to make up missed work. Per their independent discretion, individual instructors may determine how attendance affects students' ability to meet course learning objectives and whether attendance affects course grades.

Campus Closure

To ensure the health and safety of students and employees, college administrators may decide it is necessary on rare occasions to close the campus. In order to make progress toward the courses' objectives, instructors have the freedom during most campus closures to require students to participate in activities as alternatives to meeting on campus. An instructor may, for example, hold class remotely (through Zoom) at the scheduled time, provide a recording of a class or presentation for students to watch independently, or assign other activities that students are to accomplish before returning to campus. Students are responsible for accomplishing these alternative activities as well as any course requirements listed in this syllabus during the period of the campus closure. If, during the period of the campus closure, personal circumstances prohibit a student from accomplishing these alternative activities or course requirements and assignment listed in the syllabus during the campus closure, the student is responsible for communicating with the instructor as soon as possible. Instructors will not penalize students who do not have the means to accomplish the alternative activities during the period of the campus's closure and will work with students whose circumstances during the campus closure prohibited their timely completion of course requirements and assignments in the syllabus.

Incomplete Grades

Students requesting a grade of Incomplete (I) must understand that incomplete grades may be given only upon approval of the faculty member involved. An "I" may be assigned only when a student is currently passing a course and in situations involving extended illness, serious injury, death in the family, or employment or government reassignment, not student neglect.

Students are responsible for contacting their instructors prior to the end of the semester, plus filing the appropriate completed and approved academic request form with the Registrar's Office. The "I" must be removed (by completing the remaining course requirements) no later than 60 calendar days after the close of the term or semester in which the grade was awarded, or the "I" will become an "F."
