#### **Course Description and Prerequisites**

An introductory writing course that includes instruction in practical reasoning and the principles of rhetoric. Prerequisite: ENG 090 or required minimum ACT or SAT score.

## **Course Objectives**

- a. Create a strategy for tackling and completing assignments in multiple courses
- **b.** Engage with readings actively and efficiently
- **c.** View readings/sources as part of a larger academic conversation
- d. Join the academic conversation (in class and in papers) with clear claims, reasons, and evidence
- e. Organize papers logically
- **f.** Become familiar with rhetorical strategies in papers
- g. Write with clarity, using standard American English
- h. Format papers using Turabian manual
- i. Develop editing skills

If your version of our textbook does not have a grammar handbook, I strongly encourage you to purchase one. Also, since Criswell Manual of Style is based on Turabian, you may want to purchase the 9<sup>th</sup> edition of Turabian, especially if you prefer hard copies to PDFs.

## **Course Requirements and Assignments**

- a. Daily work and participation. This portion of your grade will be earned by coming to class with the daily assignments and readings done along with your readiness to participate in class discussions. [20%]
- **b.** Smaller writing assignments: literacy narrative, abstract, response paper. These assignments will work on analysis, summary, and argumentation. Each of these papers must be turned in to Canvas. (30%)
- c. Grammar Quizzes. (20%)
- **d.** Global Revision or Portfolio: Students will have the choice of either a complete revision including format and audience of a prior writing assignment or a portfolio that revises all three previous assignments. [30%]

## **Course/Classroom Policies and Information**

- I reserve the right to ask a student to leave if he or she is being disruptive or uncooperative.
- Technology is welcome in the classroom unless it becomes a distraction.
- Daily work must be completed by the start of each class period; no late work will be accepted.
- Writing assignments and the final research essay are due by 11:59 PM on the scheduled class day: 10point late penalty per day after that. Every student is allowed one extension, which allows her to notify
  me (before the deadline) and receive an extra week to complete the writing assignment with no
  penalties.
- Professors work closely with the Student Success Manager Jeremy Bugh (jbugh@criswell.edu). To help
  provide resources to students who may need it most, I will communicate the names of students who
  have two consecutive absences, low grades, or any other signs that they may be struggling. The
  Student Success Manager will reach out to these students and help find appropriate resources.

#### **Class Attendance**

Students are responsible for enrolling in courses for which they anticipate being able to attend every class session on the day and time appearing on course schedules, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any information missed. Instructors are not obliged to allow students to make up missed work. Per their independent discretion, individual instructors may determine how attendance affects students' ability to meet course learning objectives and whether attendance affects course grades.

Students can miss four class periods, but on the fifth absence, the student's grade may be affected.

#### **Campus Closure**

To ensure the health and safety of students and employees, college administrators may decide it is necessary on rare occasions to close the campus. Once this decision is announced, instructors will contact students to provide further details regarding the campus closure's impact on those courses. Students are responsible to watch for communication from their instructors and respond appropriately. (Unless otherwise specified by the instructor in this syllabus, this communication will be sent to the student's Criswell College e-mail account.)

In order to make progress toward the courses' objectives, instructors have the freedom during most campus closures to require students to participate in activities as alternatives to meeting on campus. An instructor may, for example, hold class remotely (through Zoom) at the scheduled time, provide a recording of a class or

presentation for students to watch independently, or assign other activities that students are to accomplish before returning to campus. Students are responsible for accomplishing these alternative activities as well as any course requirements listed in this syllabus during the period of the campus closure. If, during the period of the campus closure, personal circumstances prohibit a student from accomplishing these alternative activities or course requirements and assignment listed in the syllabus during the campus closure, the student is responsible for communicating with the instructor as soon as possible. Instructors will not penalize students who do not have the means to accomplish the alternative activities during the period of the campus's closure and will work with students whose circumstances during the campus closure prohibited their timely completion of course requirements and assignments in the syllabus.

## **Incomplete Grades**

Students requesting a grade of Incomplete (I) must understand that incomplete grades may be given only upon approval of the faculty member involved.
