# **Course Description and Prerequisites**

An intensive study of the historical, social, and literary contexts of the New Testament. (Prerequisites: NTS 101, NTS 201)

## **Course Objectives**

At the end of the course, the student should be familiar with:

- 1. The historical context of the New Testament and how it affects our understanding of the NT.
- 2. The literary context of the New Testament and how to use primary sources in NT exegesis.
- 3. A variety of cultural contexts that affect our understanding of earliest Christians' experiences.
- 4. The application of the course contents to specific New Testament passages.

# **Course Requirements and Assignments**

- 1. Book Report (20%) Students are required to read *The Lost Letters of Pergamum* and to write a 2-page single-spaced book report. The first page should summarize the contents of the book, and the second page should explain how the book has affected their understanding of New Testament backgrounds. The report is due by March 31.
- 2. Midterm Exam (25%) Students will complete a midterm exam on Canvas by March 22. The exam will be posted on March 10 after class. The class session on March 10 will review the contents of the exam. Topics will include the contents of the class up to Spring Break.

- 3. Final Exam (25%) Students will complete a final exam on Canvas by May 13. The exam will be posted on May 5 after class. The class session on May 5 will review the contents of the exam. Topics will include the contents of the class after Spring Break.
- 4. Research Paper (30%) Students will write an 8 to 10-page double-spaced research paper on a topic of their choice related to New Testament backgrounds. The paper must include a summary of the backgrounds area, direct interaction with at least one primary source, at least four additional secondary sources, and application of the backgrounds area to one New Testament passage. A student may turn his or her paper in at any time during the semester for evaluation and grading. He or she will be able to resubmit the paper if desired as long as the submission was made before May 1. Final submissions are due by May 13.

# **Course/Classroom Policies and Information**

### **Class Attendance**

Students are responsible for enrolling in courses for which they anticipate being able to attend every class session on the day and time appearing on course schedules, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any information missed. Instructors are not obliged to allow students to make up missed work. Per their independent discretion, individual instructors may determine how attendance affects students' ability to meet course learning objectives and whether attendance affects course grades.

# **Campus Closure**

To ensure the health and safety of students and employees, college administrators may decide it is necessary on rare occasions to close the campus. Once this decision is announced, instructors will contact students to provide further details regarding the campus closure's impact on those courses. Students are responsible for accomplishing these alternative activities as well as any course requirements listed in this syllabus during the period of the campus closure. If, during the period of the campus closure, personal circumstances prohibit a student from accomplishing these alternative activities or course requirements and assignment listed in the syllabus during the campus closure, the student is responsible for communicating with the instructor as soon as possible. Instructors will not penalize students who do not have the means to accomplish the alternative activities during the period of the campus's closure and will work with students whose circumstances during the campus closure prohibited their timely completion of course requirements and assignments in the syllabus.

## **Incomplete Grades**
