## **Course Description and Prerequisites**

This course addresses issues that are foundational to the study of politics, including, but not limited to, political legitimacy, justice, liberty, equality, and citizenship. The course places an emphasis on why, when, and how individuals choose to act collectively.

## **Course Objectives**

At the end of this course, students should demonstrate the ability to:

- 1. Articulate a broad, cohesive political theory;
- 2. Describe the weaknesses and strengths of different approaches to prominent questions of political theory;
- 3. Apply their own political theory to real-world issues—both historical and contemporary;
- 4. Relate claims and tenets about Christ, Christianity, and Scripture to their political theory.

#### **Required Textbooks**

Plato. Republic.

Niebuhr, Reinhold. Moral Man and Immoral Society.

Arendt, Hannah. Eichmann in Jerusalem.

Other reading selections include: Thomas Hobbes' Leviathan, Kurt Vonnegut's Harrison Bergeron, The UN Declaration of Human Rights.

## **Course Requirements and Assignments**

1. Readings and Chapter Reviews: Discussion in class about each week's readings and weekly review questions (at the end of each chapter). On occasion, the online review questions may be replaced by the

- requirement for a one page reading or discussion summary from the student about the material from that week's chapter. 30% of the course grade.
- 2. Mid-Term Paper: a draft of the student's developed political theory taking into consideration the subject matter of the course to the mid-point of the semester. 30% of the course grade.
- 3. Term Paper: a final version of the student's political theory taking into consideration the course's content and the student's own political and theological convictions. Topics must include: the extent and limitations of political authority, representation and political legitimacy, rights and justice, and international authority. 40% of the course grade. The paper is to be submitted in person and reviewed with the professor in private conference with the student.

#### **Class Attendance**

Students are responsible for enrolling in courses for which they anticipate being able to attend every class session on the day and time appearing on course schedules, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any information missed. Instructors are not obliged to allow students to make up missed work. Per their independent discretion, individual instructors may determine how attendance affects students' ability to meet course learning objectives and whether attendance affects course grades.

#### **Campus Closure**

To ensure the health and safety of students and employees, college administrators may decide it is necessary on rare occasions to close the campus. Once this decision is announced, instructors will contact students to provide further details regarding the campus closure's impact on those courses. Students are responsible to watch for communication from their instructors and respond appropriately. (Unless otherwise specified by the instructor in this syllabus, this communication will be sent to the student's Criswell College e-mail account.)

In order to make progress toward the courses' objectives, instructors have the freedom during most campus closures to require students to participate in activities as alternatives to meeting on campus. An instructor may, for example, hold class remotely (through Zoom) at the scheduled time, provide a recording of a class or presentation for students to watch independently, or assign other activities that students are to accomplish before returning to campus. Students are responsible for accomplishing these alternative activities as well as any course requirements listed in this syllabus during the period of the campus closure. If, during the period of the campus closure, personal circumstances prohibit a student from accomplishing these alternative activities or course requirements and assignment listed in the syllabus during the campus closure, the student is responsible for communicating with the instructor as soon as possible. Instructors will not penalize students who do not have the means to accomplish the alternative activities during the period of the campus's closure and will work with students whose circumstances during the campus closure prohibited their timely completion of course requirements and assignments in the syllabus.

#### **Incomplete Grades**
