

### **Executive Summary**

#### H.B. 1.12: A Bill to Clarify the Procedures for Hosting SGA Sanctioned Events

The purpose of this bill is to clarify the procedures for SGA sanctioned events. This bill comes in light of the ambiguity regarding how events will be proposed and approved. This Bill proposes that representatives who want to host SGA sanctioned events are to meet the criteria specified by Article IV. in the constitution and must report to the president for their approval. No event can be hosted as having been sponsored by the SGA without the approval of the president. However, the President's decision regarding an event can be overturned with a four-fifths vote from the House of Representatives. The theme, structure, and execution of the event is to be left to the discretion of both the representative holding the event and the president. If funds for the event need to be raised, the event must be brought to the House of Representatives for its approval. If necessary, a committee will be established to oversee the event. This committee will be established by the Representative holding the event and the President.

## A Bill to Clarify the Procedures for Hosting SGA Sanctioned Events

- **WHEREAS,** The procedures for hosting events as SGA sanctioned with SGA representatives is not specified. This bill proposes to clarify those procedures.
- WHEREAS, If an SGA representative desires to host an SGA sponsored event, they are required to meet the requirements of Article IV. In the constitution and report to the president for the event's approval. No event can be sanctioned as an SGA sponsored event without the approval of the president. However, the president's decision regarding an event can be overturned with a four-fifths vote from the house of representatives: as consistent with the constitution (Article II. Section VII.).
- **WHEREAS,** The theme, structure, and execution of the event is to be left to the discretion of both the representative holding the event and the president.
- **WHEREAS,** If necessary, a committee will be established to oversee the event. This committee will be established by the Representative holding the event and the president.
- **WHEREAS,** If funds for the event need to be raised, the event must be brought to the House of Representatives for its approval.
- **BE IT RESOLVED**, The Student Government Association of Criswell College supports Bill H.B.1.12; and therefore,
- **BE IT RESOLVED,** That representatives are required to meet the criteria specified in Article IV. in the constitution and are required to report to the president for the event's approval. No event can be sanctioned as an SGA sponsored event without the



approval of the president. However, the president's decision regarding an event can be overturned with a four-fifths vote from the house of representatives: as consistent with the constitution (Article II., Section VII.).

**BE IT RESOLVED,** That the theme structure, and execution of the event is to be left to the discretion of both the representative holding the event and the president.

- **BE IT RESOLVED,** If necessary, a committee will be established to oversee the event. This committee will be established by the Representative holding the event and the president.
- **BE IT RESOLVED,** That if funds for the event need to be raised, the event must be brought to the House of Representatives for its approval.
- **BE IT FURTHER RESOLVED**, That a copy of this Bill be sent to the office of the student Government President, Judiciary, Student Services Office, and the Police Department of Criswell College.
