

Executive Summary

H.B. 1.5: A Bill to Require the SGA President to report any and all Title IX reports made to the Student Government

The purpose of this Bill is to ensure that the President and any member of the Student Government that is made aware of a Title IX report is required to report such instances to the colleges Vice President of Student Affairs and the Title IX representative. This Bill comes in light of the Student Governments online form that is intended for recommendations and a means of direct suggestions made to the Student Government on behalf of students. As it stands the SGA President is the sole person with access to the form's online responses. This Bill is meant to act as an internal check and balance on the President from the House of Representatives. The wording also includes a requirement for any member of the Student Government to report such instances to ensure Government wide standards.

A BILL TO REQUIRE THE SGA PRESIDENT TO REPORT ANY AND ALL TITLE IX REPORTS MADE TO THE STUDENT GOVERNMENT

WHEREAS, The Student Government Association is committed to transparency in every facet of Government **AND**;

WHEREAS, The House of Representatives hereby requires the President to report any and all reports that are relating to Title IX that come through the Student Governments online recommendation form AND,

WHEREAS, The Student Government President must report any and all instances to the Colleges Vice President of Student Affairs and Title IX Representatives office, any member of Government that may be granted access to the forms responses are hereby held to the same standards set forth by this Bill for the President; AND,

WHEREAS, Any and all members of the Student Government who are made aware of Title IX reports must make the Colleges Vice President of Student Affairs and Title IX Representatives office aware of the report. The member must disclose to the Student Government Presidents Chief of Staff that a report is being made; the member does not have to disclose details to the Chief of Staff. AND THEREFORE,

BE IT RESOLVED,

The Student Government Association of Criswell College supports a bill requiring THE SGA PRESIDENT TO REPORT ANY AND ALL TITLE IX REPORTS MADE TO THE STUDENT GOVERNMENT

AND THEREFORE,

BE IT FURTHER RESOLVED, That a copy of this resolution be sent to the office of the President, and Supreme Court of the Student Government.
