



## **Executive Summary**

### **H.B. 2.2: A Bill Specifying The Temporary Repeal of the Elections Code**

---

The purpose of this bill is to temporarily repeal the elections code specifically Art. 2 Sect. 2. B.B.1. This is in response to the current amount of vacancies that have been experienced this session. This is regarding the appointment of representatives to the current vacancy in the House of Representatives. This bill proposes that any and all temporary repeals must be approved by the House of Representatives by means of legislation. Furthermore, in support of the legislation, the President and Speaker of the House must write a statement specifying the reason for this temporary repeal. This statement will be examined by both the House of Representatives and the Supreme Court to assure that this temporary repeal may not be abused. This bill is to follow the guidelines specified in H.B.1.9. The representative who fills this vacancy will serve the remainder of the vacant Representatives term. The Election Code shall be re-instated in full upon the Presidents nomination of an elections commissioner in the Spring Semester.
