### **Course Description and Prerequisites**

A study of the transmission and translation of the Scriptures and of the principles and procedures of their interpretation and application.

### **Course Objectives**

By the end of this course, the student should be able to:

- 1. Discuss the history and philosophy of English Bible translation.
- 2. Understand the current presuppositions and methodologies of Biblical interpretation.
- 3. Articulate and advocate for a specific model of Biblical interpretation.
- 4. Distinguish between the various genres present in the Bible, categorize texts by genre, and recognize the differences necessary in interpretation between genres.
- 5. Utilize appropriate tools when interpreting Scripture.

### **Course Requirements and Assignments**

1. Reading (15%): Students are expected to complete all assigned reading. The student should read *Grasping God's Word* in its entirety, and *Come and See* in its entirety, according to the schedule below. Students must

- submit their reading report (a one question "quiz" asking how much of the reading the student completed) on Canvas by 11:00 PM (CST) on **May 6**.
- 2. Quizzes (25%): Students will take weekly quizzes over the assigned reading in *Grasping God's Word*. These quizzes will be *open book* and should be taken in conjunction with the assigned reading. All quizzes are available at the start of the semester; each week's quiz must be completed by 4:45 PM (CST) on the day in which we will discuss the chapter (see schedule below); the quizzes will lock at the start of class on the day assigned and will no longer be accessible. The lowest two scores will be dropped.
- 3. Participation (15%): after completing the required readings, students are expected to be able to discuss the topics at hand with an emphasis on critical evaluation. As such, regular and thoughtful participation in class discussion is required of all students. As a rule of thumb, each student should be prepared to share with the class at least one question from the assigned reading, in addition to being able to participate in discussion. One-third of the participation score (5% of the class score) will come from in-class discussion and participation. Two-thirds of the participation score (10% of the class score) will come from the completion of five "participation assignments" through the course of the semester.
- 4. Essay (15%): Students will compose a 3–5 page essay. Students may choose from these topics: (1) Who determines meaning? (2) How does one account for interpretive/theological presuppositions? (3) How does one move from interpretation to application? The essay must be turned in on Canvas by 11:00 PM (CST) on May 8.
- 5. Final Exam (30%): Students will take a final exam that will cover material from our assigned readings *and* class lectures. The exam will be a combination of multiple choice, matching, and true-false style questions. There will be a review session available before taking the exam. The final exam will be due by **May 6**. The exam must be *COMPLETED* on Canvas by 11:00 PM (CST).

### **Course/Classroom Policies and Information**

All assignments are *DUE BY THE DEADLINES LISTED IN THIS SYLLABUS*. Any late submissions will be docked one letter grade per day.

Students may record class sessions, though these should not be distributed without the professor's permission.

Computers are allowed to be employed during class. *Please* use them appropriately and for class purposes only. Cell phone use should be avoided.

Students should not use earbuds during class. If there is a *medical condition* that necessitates earbuds (for noise-canceling purposes, etc.), the professor *must* be notified.

Fellow students should be treated with respect and dignity. Critical evaluation of our readings, lectures, and discussions will be welcomed, but it should always be carried out in a spirit of generosity toward our dialogue partners.

Arriving to class by more than fifteen (15) minutes late or departing class more than fifteen (15) minutes early will count as an absence unless approved in advance by the instructor. Students are allowed two (2) unexcused absences for this course. After this, each unexcused absence will result in a letter-grade deduction in final grade. Thus, six (6) unexcused absences will result in the student failing the course.

#### **Class Attendance**

Students are responsible for enrolling in courses for which they (1) anticipate being able to attend every oncampus class session on the day and time appearing on course schedules, or (2) participating in academically related activities as identified in online-course schedules including synchronous class sessions conducted remotely by video, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any missed information. Professors are not obliged to allow students to make up missed work. Per their independent discretion, individual professors may determine how attendance affects students' ability to meet course learning objectives and whether attendance affects course grades. Professors apprise students of such information in course syllabi.

Students receiving grants, loans, or scholarships must meet specified requirements of various departments at the college and should consult relevant sections of the *Academic Catalog*. To ensure such funds will not be forfeited, students are responsible for contacting the proper departments to ascertain any specific course participation requirements and consequences of not meeting such requirements. Students receiving grants, loans, or scholarships should consult the Financial Aid office.

While Criswell College is a non-attendance taking institution, it nevertheless must demonstrate that students begin their courses in order to comply with Federal Aid regulations. Accordingly, students must participate in academically related activities during census periods. Failure to meet this requirement will result in students being administratively dropped from courses.

Academically related activity is defined as any course-related activity that may be used as evidence of attendance. Examples include:

- physical presence in a classroom during a class session with the instructor present,
- participation in a synchronous remote video class session with the instructor present,
- submission of an academic assignment, quiz, or exam,
- participation in an interactive tutorial or computer-assisted instruction,
- participation in a study group or discussion board that is assigned by the instructor,
- documentation showing that the student and a faculty member corresponded about the academic subject of the course.

**NOTE:** Logging into a Canvas course alone and logging into a Synchronous Online class session without active participation or with the camera off are not considered attendance.

**NOTE:** A census period begins on the first day of a semester/term and runs through the end of the last day to drop courses. During the census period, attendance data is collected in order to demonstrate compliance with Federal Aid regulations. There is no census period for winter terms since there is no last day to drop courses.

#### **Campus Closure**

To ensure the health and safety of students and employees, college administrators may decide it is necessary on rare occasions to close the campus. Once this decision is announced, instructors will contact students to provide further details regarding the campus closure's impact on those courses. Students are responsible to watch for communication from their instructors and respond appropriately. (Unless otherwise specified by the instructor in this syllabus, this communication will be sent to the student's Criswell College e-mail account.)

In order to make progress toward the courses' objectives, instructors have the freedom during most campus closures to require students to participate in activities as alternatives to meeting on campus. An instructor may, for example, hold class remotely (through Zoom) at the scheduled time, provide a recording of a class or presentation for students to watch independently, or assign other activities that students are to accomplish before returning to campus. Students are responsible for accomplishing these alternative activities as well as any course requirements listed in this syllabus during the period of the campus closure. If, during the period of the campus closure, personal circumstances prohibit a student from accomplishing these alternative activities or course requirements and assignment listed in the syllabus during the campus closure, the student is responsible for communicating with the instructor as soon as possible. Instructors will not penalize students who do not have the means to accomplish the alternative activities during the period of the campus's closure and will work with students whose circumstances during the campus closure prohibited their timely completion of course requirements and assignments in the syllabus.

### **Incomplete Grades**

Students requesting a grade of Incomplete (I) must understand that incomplete grades may be given only upon approval of the faculty member involved. An "I" may be assigned only when a student is currently passing a course and in situations involving extended illness, serious injury, death in the family, or employment or government reassignment, not student neglect.

Students are responsible for contacting their instructors prior to the end of the semester, plus filing the appropriate completed and approved academic request form with the Registrar's Office. The "I" must be removed (by completing the remaining course requirements) no later than 60 calendar days after the close of the term or semester in which the grade was awarded, or the "I" will become an "F."

Academic honesty is the application of the principle of truth in the classroom setting. Academic honesty includes the basic premise that all work submitted by students must be their own and any ideas derived or copied from elsewhere must be carefully documented.

Academic dishonesty includes, but is not limited to:

- cheating of any kind,
- submitting, without proper approval, work originally prepared by the student for another course,
- plagiarism, which is the submitting of work prepared by someone else as if it were his own, and
- failing to credit sources properly in written work.

#### **Institutional Assessment**

Material submitted by students in this course may be used for assessment of the college's academic programs. Since programmatic and institutional assessment is done without reference to specific students, the results of these assessments have no effect on a student's course grade or academic standing at the college. Before submitting a student's work for this type of assessment, the course instructor redacts the work to remove anything that identifies the student.
