Course Description and Prerequisites

A continuing advanced study of sermon delivery mechanics with a focused emphasis on expository sermons from varying genres. (Prerequisite may be taken concurrently: MIN 701)

Course Objectives

At the end of this course, the student should demonstrate the ability to:

- 1. plan, organize, prepare, write, and deliver sermons from the Bible based on sound methods,
- 2. contextualize (from interpretation to application) Biblical passages,
- 3. communicate effectively the Word of God to a contemporary audience,
- 4. demonstrate measurable improvement and the ability to improve in the future regarding all of the above.

Course Requirements and Assignments

The student's grade is based on **FIVE factors**:

- 1. Class Participation (30%). Repeated exposure to the process of sermon/lesson development and the input of the professor and other students in the class is vital to the purpose of the course. Perfect class participation results from perfect attendance. Attendance will be taken in class and tracked in Canvas.
- **2. Text Preparation (Sermon Outlines)(20%).** Students who preach are expected to do significant sermon preparation work on passages before the class period for which preaching is scheduled. The student must turn in an expository sermon outline for each text preached.
- **3. Sermon Critiques (Sermon Feedback)(20%).** The students will either present or preach (depending on the number of students) exegetical/expository sermons or lectures as required throughout the semester. Each student in class not preaching is responsible for critiquing the others who do preach. For every sermon delivered, each student in class not presenting must complete a sermon critique form.
- 4. Reading Reports (10%). Students will be required to complete a three-page summary/reaction to the assigned readings. These three-page summary/reaction papers should cover the general content of the readings as well as noting any significant strengths or weaknesses of the readings in relation to preaching. These assignments are turned in through canvas. The student must turn in a summary/reaction paper for each set of assigned readings to be eligible for an A.
- 5. Research Paper (20%). The student must also prepare a research paper on a Biblical text chosen during the semester. The paper should make use of at least ten separate non-internet-based sources (three of which should be the assigned texts for class). The paper should have a section covering exegesis and a section consisting of an expanded sermon outline that contains the main functional elements of an expository sermon (introduction, explanation, illustration, application for each main point, and conclusion)(2/3 exegesis; 1/3 expanded outline). This paper is not less than ten pages long (not including the cover page or bibliography; ten pages of content). The paper is due no later than midnight the day of the final. Each day it is late will cost the student one letter grade on the paper. Short papers will lose one letter grade. Papers with significant formatting errors will lose one letter grade. Adherence to Chicago Manual of Style (Turabian current edition) is required. Since the final is a synthetic demonstration of everything covered in the semester, students who do not complete the final cannot pass the course and will receive a failing grade.

Class Attendance

Students are responsible for enrolling in courses for which they (1) anticipate being able to attend every on-campus class session on the day and time appearing on course schedules, or (2) participating in academically related activities as identified in online-course schedules including synchronous class sessions conducted remotely by video, and then making every effort to do so. When unavoidable situations result in absence or tardiness, students are responsible for acquiring any missed information. Professors are not obliged to allow students to make up missed work. Per their independent discretion, individual professors may determine how attendance affects students' ability to meet course learning objectives and whether attendance affects course grades. Professors apprise students of such information in course syllabi.

Students receiving grants, loans, or scholarships must meet specified requirements of various departments at the college and should consult relevant sections of the *Academic Catalog*. To ensure such funds will not be forfeited, students are responsible for contacting the proper departments to ascertain any specific course participation requirements and consequences of not meeting such requirements. Students receiving grants, loans, or scholarships should consult the Financial Aid office.

While Criswell College is a non-attendance taking institution, it nevertheless must demonstrate that students begin their courses in order to comply with Federal Aid regulations. Accordingly, students must participate in academically related

activities during census periods. Failure to meet this requirement will result in students being administratively dropped from courses.

Academically related activity is defined as any course-related activity that may be used as evidence of attendance. Examples include:

- physical presence in a classroom during a class session with the instructor present,
- participation in a synchronous remote video class session with the instructor present,
- submission of an academic assignment, quiz, or exam,
- participation in an interactive tutorial or computer-assisted instruction,
- participation in a study group or discussion board that is assigned by the instructor,
- documentation showing that the student and a faculty member corresponded about the academic subject of the course.

NOTE: Logging into a Canvas course alone and logging into a Synchronous Online class session without active participation or with the camera off are not considered attendance.

NOTE: A census period begins on the first day of a semester/term and runs through the end of the last day to drop courses. During the census period, attendance data is collected in order to demonstrate compliance with Federal Aid regulations. There is no census period for winter terms since there is no last day to drop courses.

Campus Closure

To ensure the health and safety of students and employees, college administrators may decide it is necessary on rare occasions to close the campus. Once this decision is announced, instructors will contact students to provide further details regarding the campus closure's impact on those courses. Students are responsible to watch for communication from their instructors and respond appropriately. (Unless otherwise specified by the instructor in this syllabus, this communication will be sent to the student's Criswell College e-mail account.)

In order to make progress toward the courses' objectives, instructors have the freedom during most campus closures to require students to participate in activities as alternatives to meeting on campus. An instructor may, for example, hold class remotely (through Zoom) at the scheduled time, provide a recording of a class or presentation for students to watch independently, or assign other activities that students are to accomplish before returning to campus. Students are responsible for accomplishing these alternative activities as well as any course requirements listed in this syllabus during the period of the campus closure, personal circumstances prohibit a student from accomplishing these alternative activities or course requirements and assignment listed in the syllabus during the campus closure, the student is responsible for communicating with the instructor as soon as possible. Instructors will not penalize students who do not have the means to accomplish the alternative activities during the period of the campus's closure and will work with students whose circumstances during the campus closure prohibited their timely completion of course requirements and assignments in the syllabus.

Incomplete Grades

Students requesting a grade of Incomplete (I) must understand that incomplete grades may be given only upon approval of the faculty member involved. An "I" may be assigned only when a student is currently passing a course and in situations involving extended illness, serious injury, death in the family, or employment or government reassignment, not student neglect.

Students are responsible for contacting their instructors prior to the end of the semester, plus filing the appropriate completed and approved academic request form with the Registrar's Office. The "I" must be removed (by completing the remaining course requirements) no later than 60 calendar days after the close of the term or semester in which the grade was awarded, or the "I" will become an "F."
