Course Description and Prerequisites

An intensive study of Genesis in the English Bible with special attention to literary structure and features, historical and cultural setting, and biblical theology. (prerequisite: OTS 101; prerequisite may be taken concurrently: OTS 201)

Course Objectives

Upon completion of the course, you should be able to...

- A. Describe the occasion, message, structure and genres of the book;
- B. Identify and summarize the critical, introductory issues relating to the origins of Genesis;
- C. Place in sequence the events and people in each chapter of Genesis;
- D. Relate ancient Near Eastern literature and customs to the book
- E. Perform basic scholarly research on an exegetical, theological, or cultural topic in Genesis; and
- F. Apply the content of the book to contemporary living.

Required Textbooks

The Holy Bible. You may use a version of your choice. The professor will use the ESV and NKJV and reference to the Hebrew Old Testament.

Course Requirements and Assignments

A. Read the book of Genesis (5) times, each time in a different version. Report these readings in Canvas with the OTS 310 Genesis "Bible Reading Report." The course calendar below and the report form show the due dates for each of the readings.

Suggested versions are CSB, ESV, JPSV, KJV, NAB, NASB, NIV, NJB, NKJV, NLT, NRSV, and REB. Most of these versions can be accessed on Bible Gateway and on Bible Hub.

- B. Read the commentary according to the schedule we follow for class discussion, since we will discuss the views expressed in it. Report your reading on Canvas with the “Commentary Reading Schedule.”
- C. Quizzes on the content of Genesis. Simple quizzes checking your ability to know in which chapters certain events, characters, and topics are found.
- D. Write an 18-20-page research paper on a topic in Genesis. It may be exegetical, theological, cultural, literary, historical, or geographical. Suggested topics are given on Canvas. Use the Turabian footnote/bibliography reference method, not the parenthetical reference/works cited method.
- E. Type a list of contemporary practical applications from Genesis. From your reading, study and assignments, form a list of practical applications to contemporary life, two applications from each of the 50 chapters in Genesis, for a list of 100. Each application must be in the form of one complete sentence. Give the scripture reference (chapter and verse) with the application. Applications are due late in the semester, but applications should be started from the beginning of the semester.
- F. Two Exams. These are primarily objective tests, but with some short essays, all based on the in-class discussions, lectures, and quizzes.
- G. Write four preliminary lesson plans from the book of Genesis:
1. **Applications are due late in the semester, but applications should be started from the beginning of the semester.**
 2. Examine four passages in Genesis as if you were planning to teach them. Then for each passage:
 3. Write the overall idea of what happened.
 4. Report what group you would be teaching, e.g., early elementary, middle school, church camp, military, women, singles, elderly, school or college chapel, an assembly of international missionaries, refugees, the homeless. You may select a grouping different than these, also.
 5. Report what your three aims are:
 - a. Cognitive (i.e., intellectual) aim: what is the major fact you want them to grasp?
 - b. Affective (i.e., emotive/emotional) aim: what is the major truth you want them to value?
 - c. Behavioral (i.e., volitive/volitional) aim: what is the main action you want them to decide to take? (this action may be belief, and the belief will lead to certain actions). (Note: The Holy Spirit will direct different people to apply the message in ways that relate to their specific situation. You cannot know this, but you can give a general direction as you are led by the text and the Spirit.)
 6. What are the major three or four “points” you would use to teach the passage. These should be consistent with the overall idea of the passage and should reflect the stages in the flow of the passage. Do not merely state the event in a part of the passage but make it general enough to fit your audience. For example, instead of saying, “Joseph’s brothers sold him to be a slave,” you might say, “Hatred and jealousy make us mistreat people we should love.” Or, when Baraq was slow to obey and originally refused to obey, instead of, “Deborah told Baraq the glory for defeating the enemy commander would go to a woman,” you might say, “When we resist obeying the Lord we may miss the blessing God would like to give us.” Instead of saying, “Samson’s hair was cut and the Holy Spirit left him,” you might say, “Don’t get your hair cut or the Holy Spirit will abandon you” Okay, maybe that’s not a good one!

7. Report your plan for the introduction, that is, how you would
 - a. Get audience attention
 - b. Get audience interest in the subject
 - c. Lead your audience to the passage
8. Briefly report how you would conclude the lesson
 - a. Summarize your major point in one brief sentence.
 - b. Challenge the audience in relation to your behavioral/volitional aim.

Pay attention to spelling, grammar, and writing style. The first page must include the title of the lesson series.

Video Recording

To ensure FERPA compliance when a course is live-streamed or recorded, students can opt out of video recordings by requesting seating in a designated area off camera. Students who sit outside of this area are giving implicit permission to be recorded.

Class Attendance:

Students should only enroll in courses they are able to attend regularly.

Important Note:

Simply logging into Canvas or a Zoom session without participating (e.g., camera off, no interaction) **does not count** as attendance.

Canvas:

- Criswell College uses Canvas as its web-based Learning Management System (LMS).
- **For online courses** at Criswell College, instructors use Canvas to:
 - Organize course content on a module basis using organizational tools within Canvas
 - Control the timing of course requirements through module control or assignment due dates to ensure that students are engaged for the full length of the semester or term
 - Accept assignments from students only inside the Canvas course (emailed assignments are not acceptable)
 - Provide written feedback on assignments only within Canvas, preferably through Speedgrader
 - Use the Announcement or e-mail feature in Canvas to communicate with the students rather than by broadcasting to a class email listserv outside of canvas
 - Use Zoom in Canvas for all “live” (synchronous) class sessions

Campus Closure

To ensure the health and safety of students and employees, college administrators may decide it is necessary on rare occasions to close the campus. Incomplete Grades

Students requesting a grade of Incomplete (I) must understand that incomplete grades may be given only upon approval of the faculty member involved. Examples of AI-related functions you **may not use** without permission:

- Text Generation – You may not use AI to generate text for use in an assignment.
- Outline Generation – You may not use AI to generate an outline for an assignment.

AI-related tools you **may use** without permission:

- Spellcheck and grammar – built into Word, Pages, and Google Docs
- AI re-writing tools – tools that take what you’ve written and help make it clearer, such as what Grammarly offers. However, you must cite Grammarly or other sources in your assignment/paper and submit both original draft of paper and the final paper.
- AI research and summarize – tools that help you find sources to cite, such as the new AI tools built into Logos Bible Software.)

Material submitted by students in this course may be used for assessment of the college’s academic programs. Since programmatic and institutional assessment is done without reference to specific students, the results of these assessments have no effect on a student’s course grade or academic standing at the college. Before submitting a student’s work for this type of assessment, the course instructor redacts the work to remove anything that identifies the student.
